This presentation will address issues of privacy and free speech in digital applications. Technology provides unprecedented access to information, links people around the world, and gives voice to those who might not otherwise be heard. However, if deployed without adequate protections for privacy and free speech, it can become a tool that tramples constitutional rights. Ms. Jennifer McAllister will present the legal aspects of privacy and free speech while Mr. Cartelli will address the technical aspects of privacy in the digital age.

JENNIFER MCALLISTER is a 2011-12 Law Graduate Fellow at Santa Clara University School of Law, from which she earned her J.D. She is also a freelance legal writer and researcher. Jennifer has been a member of the ACLU-SCV Board of Directors since 2009, and currently serves as the Alternate Chapter Representative to the ACLU-NC board.

ROBERT CARTELLI has served on the ACLU-SCV board since 2009 in the role of Communications Chair, and for the past year as Board Chairperson. A computer engineer by profession, Robert continues to work for the University of California at Santa Cruz where he has been for the past seven years. Starting in 2012, he will be lecturing at UCSC Extension in Santa Clara. Before UCSC, Robert worked for Citrix and Exodus Communications among other companies in Silicon Valley. He has been an ACLU Member since 2004 and is passionate about civil liberties. Robert holds a BS in Computer Engineering from Cal Poly San Luis Obispo and a MS in Computer Engineering from San Jose State University.
